Our graduate program currently includes 16 tenured or tenure-track faculty members in CPPS, and 2 additional members from the College of Medicine. In addition, there are over a dozen faculty members on the clinical and research tracks who are also involved in the graduate education in our program. The research programs of our graduate faculty members cover a wide spectrum ranging from molecular therapeutics, nanotechnology, drug discovery/design/delivery, drug metabolism, dietary supplements, signal transduction, cancer biology, cardiovascular diseases, inflammation and arthritis, neurodegenerative diseases, to basic science research using genetic models. The research activities of our faculty members are currently supported by active grants from many institutes of NIH, including NIAMS, NHLBI, NIEHS, NINDS, NCI, NEI, NICHD, NCCIH, NIBIB, and NIGMS, as well as many private research foundations.

The rationale for this name change is to better reflect the broad research areas of our graduate faculty members and to make our program more competitive in the recruitment of graduate students with diverse research interests. In addition, it should also be beneficial to graduating students entering the job market. We believe that this change will strengthen graduate education at the WSU Spokane campus, which will complement the superb graduate education at the Pullman campus.

Implications for currently enrolled students.

There should be no impact for currently enrolled students. Only students entering the program in the fall 2020 and afterwards will graduate under the new program name.

Describe the process by which current faculty and staff were consulted about this change and summarize the response:

The proposed name change was discussed at multiple graduate faculty meetings and had overwhelming support among the members. A formal meeting was called for all of our graduate faculty to attend on October 14, 2019, with 24 of the 33 members attending. An initial vote was requested on four potential new names for the Pharm Sci Graduate Program, with faculty asked to choose their top two names; two of the names received '0' votes. In a final vote for the remaining two names, there was unanimous consensus on the name "PhD in Pharmaceutical Sciences and Molecular Medicine" (The Head of the Program, Dr. Philip Lazarus, and the Program Director, Dr. Sue Marsh, abstained from voting).

Describe the process by which other degree programs, departments, colleges or campuses were consulted about this change and summarize the response.

We have obtained support from faculty in the college of Medicine in Spokane. In addition, the Deans for the College of Arts and Sciences, College of Veterinary Medicine, and Voiland College of Engineering and Architecture were consulted by email and none had any concerns with this proposed PhD program name change.

Describe the process by which other stake holders (e.g., advisory or alumni groups) were consulted about this change and summarize the response.

The proposed name change was presented to the Dean's Advisory Council for the College of Pharmacy and Pharmaceutical Sciences, via email. The Council includes alumni and community stakeholders.
